## LOCATION

The site is located on Beach Avenue, which runs between Strode Road and Old Church Road, close to Clevedon Town Centre. Clevedon itself is a few minutes drive from junction 20 of the M5 motorway, which provides easy access to Bristol, which is located 10 miles to the north and in turn the South West.

Clevedon itself is a popular town providing a range of retail, business and other amenities which are only approximately 5 minutes walk from the proposed development.

# DESCRIPTION

The site currently benefits from planning permission for 3 self-contained office buildings, one of which has already been built and is currently occupied by AJP Partnership.

The two remaining buildings are being offered either as a pre-sale or pre-let and can be finished to suit a tenant or purchaser's specific requirements.

Each building will provide brand new open plan office accommodation, incorporating male/female WC facilities, shower and kitchen facilities and an 8 person passenger lift, therefore providing DDA access.

The units will also provide a suspended ceiling with LG7 light fittings, electric door entry system, perimeter trunking and carpet tiles throughout.
