

LOCATION

The plot of land is located fronting onto Walsingham Road in the sought after and upmarket residential area of St Andrews in Bristol. The surrounding area has a mix of detached, semi-detached and terraced residential homes and the plot of land is adjacent to a detached house and a Parish Hall.

The plot is less than 2 miles from Bristol city centre and there is excellent access to the motorway network via the M32 which leads to the M4 and the rest of the motorway network. The nearest railway station is Montpelier which is a short walk or drive from the property and has connections to Bristol Temple Meads Railway Station.

DESCRIPTION

The property comprises a self-contained plot of land which we understand previously formed part of the garden to the Church Rectory. The site measures approximately 0.09 acres and benefits from road frontage.
