DESCRIPTION

The property has an open plan seating area fitted with a coffee bar, further seating to the rear, a kitchenette and customer W.C. There is a shared staff W.C. with Hollis Morgan and a further storeroom, located on the first floor. The property carries a mix of wooden and vinyl flooring, painted plastered ceilings and walls and has been fitted with a mix of pendant and recessed spotlighting as well as air-conditioning. We understand there has formerly been commercial extraction in place.
